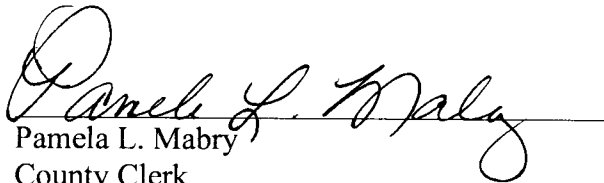

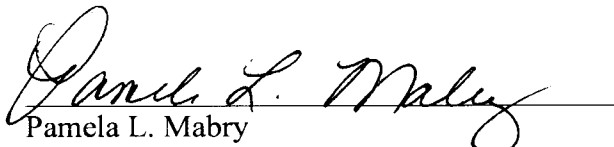

CLOSING REMARKS AND ADJOURNMENT

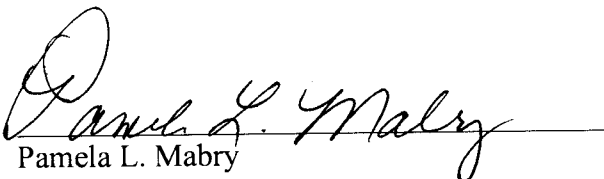
