1) Advance In-Person Voting Schedule: November 4, 2025 Municipal/Special General Election

2) Proposed Amendment to Officer Elections Bylaws

 - Precinct cards will be mailed out mid-September
- NGE – No Activity in two General Elections
 - Confirmations mailed out 7/11/2025 to approximately 37,206 voters
 - Responses Returned
 - 1 moved out of state
 - 20 reside in Cobb
 - 18 received – voter not residing at this address
 - Returned Undeliverable – unable to forward
 - 7,780 no forwarding address
 - 107 with forwarding addresses
 - NGE Clock Countdown – 2 days until cancellation on 8/20/2025
 - To date: approximately 37,185 voters to be cancelled
