Director D'Itri stated no major issues were reported and that approximately 31,700 voters were eligible to vote in the Municipal General Election Runoff.

MOTION TO RECESS UNTIL ELECTION RESULTS ARE COMPLETE

Motion by Ms. Fisher at 7:04 p.m. to move to recess until election results are complete. Second by Mr. Turner. Motion passed 4-0. Ms. Efrat was not in attendance at time of vote.

*Ms. Efrat joined the meeting after the Board motioned for recess.

Motion by Ms. Fisher at 9:08 p.m. to come out of recess. Second by Ms. Watkins. Motion passed 5-0.

Director D'Itri corrected a previous statement regarding eligible voters. The earlier number included all district combinations in the 9 precincts that were open for the Municipal General Runoff, instead of only including combinations that were eligible for Ward 3 or Ward 5. The corrected total of eligible voters for the election was 11,227.
