Absentee by Mail

- 27 ballots returned
- 25 ballots accepted
- 1 provisional ballot issued but not cured as of 6:55 p.m.

Advance In-Person Voting

- Voting was conducted Monday, December 8, through Friday, December 12
- Friday, December 12 was the busiest day with 559 ballots cast

Election Day

- 1,891 ballots cast as of 6:55 p.m.
- 21 precincts participated in the election across 17 physical locations
- Smyrna 4A and Smyrna 6A were the busiest polling locations
- Thompson Community Center reported zero turnout

Director D'Itri reported that Smyrna 4A experienced significant scanner issues, requiring the scanner to be replaced four times. While technicians were initially unable to determine the cause, an unusually hot power block was identified during the fourth replacement and was switched out. No further issues were observed following the fourth replacement. Smyrna 4A reconciled all numbers at the close of polls.
