OLD BUSINESS

1) Advance Voting Schedule for the May 19, 2026 General Primary/Nonpartisan Election

Chairwoman Mosbacher noted that Tim Lee Senior Center was added to the Advance Voting Schedule

Motion by Ms. Efrat to approve the Advance Voting schedule for the May 19, 2026 General Primary/Nonpartisan Election. Second by Ms. Watkins. Motion Passed 5-0.

2) Advance Voting Schedule for the potential June 16, 2026 Runoff

Chairwoman Mosbacher suggested tabling the potential runoff schedule until the results of the May 19 General Primary/Nonpartisan Election are known, allowing the Board to review the schedule and make an informed decision on coverage.

Ms. Fisher noted the tight timeframe for providing notice to the parties with the vote postponed.

Motion by Ms. Efrat to table the Advance Voting Schedule for the potential runoff until the Board of Elections and Registration Meeting on May 26. Second by Ms. Watkins. Motion Passed. 4-0-1. Ms. Fisher abstained.
